AMENDMENT NO. 2 TO OPERATING AGREEMENT FOR GROUND HANDLERS
TAMPA INTERNATIONAL AIRPORT

THIS AMENDMENT to that certain Operating Agreement for Ground Handlers at Tampa International Airport, dated August 3, 2017, by and between the HILLSBOROUGH COUNTY AVIATION AUTHORITY, an independent special district under the laws of the State of Florida (Authority), and QUANTEM AVIATION SERVICES, LLC, a limited liability company organized and existing under the laws of the State of Delaware and authorized to conduct business in the State of Florida (Company) (hereinafter individually and collectively referred to as Party or Parties) is entered into this 6th day of MAY, 2020 (Amendment No. 2).

WITNESSETH:

WHEREAS, Authority has the ownership, custody, control and management of Tampa International Airport (Airport) located in Hillsborough County, State of Florida; and

WHEREAS, Authority has the right to provide for the use of land, property and facilities of the Airport and has full power and authority to enter into this Amendment in respect thereof; and

WHEREAS, on August 3, 2017, Authority and Company entered into an Operating Agreement for Ground Handlers to provide ground handling services to Company's Customers (Agreement) at Airport; and

WHEREAS, on April 30, 2020, the Parties amended the Agreement to include sanitary disposal services and to amend certain administrative provisions (Amendment No. 1); and

WHEREAS, the Parties desire to extend the term of the Agreement for one year pursuant to this Amendment No. 2.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby mutually acknowledged, the Parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. ARTICLE 2, TERM, Section 2.02, Term, is hereby deleted in its entirety and replaced by the following:

2.02 Term

The term of this Agreement commences August 3, 2017 and terminates September 30, 2021, unless terminated earlier as provided herein.

3. Except as otherwise stated herein, all other terms remain in full force and effect and are hereby ratified and confirmed. The Agreement, Amendment No. 1 and this Amendment No. 2 represent the entire understanding between the Parties on the issues contained therein, either written or oral, and may be amended only by written instrument signed by both Parties.




