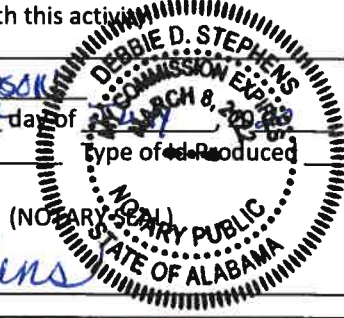

The proposed building project consists of six points, representing by ASNs 2020-ASO-9297-OE, 9299 through 9301, 9313, and 9314. The project points were submitted at a height of 234 feet AGL, 247 feet AMSL. The building points are located approximately 2.22 to 2.25 NM north of the TPF ARP and from 3.65 degrees azimuth clockwise to 4.16 degrees azimuth from TPF.

The proposal would exceed the Obstruction Standards of Title 14, Code of Federal Regulations (14 CFR), Part 77 as follows:

Section 77.17 (a)(2) TPF --- > Exceeds by 34 feet.

The proposal was not circularized for public comment because current FAA obstruction evaluation policy exempts from circularization those proposals that exceed the above cited obstruction standard. This is provided the proposal does not lie within an airport traffic pattern. This policy does not affect the public's right to petition for review determinations regarding structures, which exceed the subject obstruction standards.

Part 77 Obstruction Standards are used to screen the many proposals submitted in order to identify those which warrant further aeronautical study in order to determine if they would have significant adverse effect on protected aeronautical operations. While the obstruction standards trigger a formal aeronautical study, including circularization, they do not constitute absolute or arbitrary criteria for identification of hazards to air navigation. Accordingly, the fact that a proposed structure exceeds an obstruction standard of Part 77 does not provide a basis for a determination that the structure would be a hazard to air navigation.

Details of the structure were not circularized to the aeronautical public for comment.

AERONAUTICAL STUDY FOR POSSIBLE INSTRUMENT FLIGHT RULES (IFR) EFFECT DISCLOSED THE FOLLOWING:

- > The proposed structure would have no effect on any existing or proposed IFR arrival/departure routes, operations, or procedures.
- > The proposed structure would have no effect on any existing or proposed IFR en route routes, operations, or procedures.
- > The proposed structure would have no effect on any existing or proposed IFR minimum flight altitudes.

AERONAUTICAL STUDY FOR POSSIBLE VISUAL FLIGHT RULES (VFR) EFFECT DISCLOSED THE FOLLOWING:

- > The proposed structure would have no effect on any existing or proposed VFR arrival or departure routes, operations or procedures.
- > The proposed structure would not conflict with airspace required to conduct normal VFR traffic pattern operations at any known public use or military airports.
- > The proposed structure would not penetrate those altitudes that are normally considered available to airmen for VFR en route flight.
- > The proposed structure will be appropriately obstruction marked and lighted to make it more conspicuous to airmen flying in VFR weather conditions at night.

The proposed structures' proximity to the airport was considered and found to be acceptable.

The impact on arrival, departure, and en route procedures for aircraft operating under VFR/IFR conditions at existing and planned public use and military airports, as well as aeronautical facilities, was considered during the analysis of the structure. The aeronautical study disclosed that the proposed structure would have no substantial adverse effect upon any terminal or en route instrument procedure or altitude.

The cumulative impact (IFR/VFR) resulting for the structure, when combined with the impact of other existing or proposed structures was considered and found to be acceptable.

Therefore, it is determined that the proposed structure would not have a substantial adverse effect upon the safe and efficient utilization of the navigable airspace by aircraft or on any navigation facility and would not be a hazard to air navigation.

- At least 10 days prior to start of construction (7460-2, Part 1)
- Within 5 days after the construction reaches its greatest height (7460-2, Part 2)

Summary: Based upon the following the Florida Department of Transportation finds that the above referenced airport obstruction zoning permit application is technically consistent with s. 333.025(4), Florida Statutes, as set forth below.

Review Requirement: Section 333.025(4), Florida Statutes (F.S.), provides the Department a 15-day review period, following receipt of a complete permit application from the local government, for the construction or alteration of an obstruction which must run concurrently with the local government's permitting process, to evaluate technical consistency with this subsection. The following Comments are intended to comply with this requirement

Review Standards: To evaluate the airport obstruction zoning permit application for technical consistency with subsection 333.025(4), Florida Statutes, the department has received and reviewed the above referenced airport obstruction zoning permit application and attachments, if any, received from the Political Subdivision, for technical consistency with s.333.025(4), F.S., regarding the construction or alteration proposed by the Applicant. The Comments are not intended as legal advice and are non-binding

evaluation solely for the consideration of the Political Subdivision with regard to the application.

EVALUATION

1. Section 333.025(4) provides, in part, that:

If political subdivisions have, in compliance with this chapter, adopted adequate airport protection zoning regulations, placed such regulations on file with the department's aviation office, and established a permitting process,

a permit for the construction or alteration of an obstruction is not required from the department.

COMMENT:

1. The Political Subdivision's submittal of the airport obstruction zoning permit application to the Department's Aviation Office (AO) is accepted as a representation by the Political Subdivision that:

1. the Political Subdivision is in compliance with Chapter 333.

[whether the Political Subdivision has complied with Chapter 333 is a legal conclusion beyond the scope of this Comment and is left to the determination of the Political Subdivision]; and

2. the Political Subdivision has adopted adequate airport protection zoning regulations

[whether the political subdivision has adopted adequate airport protection zoning regulations is a legal conclusion beyond the scope of this Comment and is left to the determination of the Political Subdivision]; and

3. the Political Subdivision has placed such regulations on file with the department's aviation office

[the department's records reflect that the Political Subdivision has placed such regulations on file with department's aviation office]; and

4. the Political Subdivision has established a permitting process

[submission of an airport obstruction zoning permit application reflects the existence of a permitting

process – it is noted that the application required appropriate information and documents for evaluation of a permit including documentation showing compliance with the federal requirement for notification of proposed construction or alteration of structures and a valid aeronautical study. Adequacy of the permitting process is beyond the scope of these Comments and is left to the determination of the Political Subdivision]

If the foregoing requirements are met a permit for the construction or alteration of an obstruction is not required from the department.

2. Section 333.025(4) provides, in part, that:

Upon receipt of a complete permit application, the local government shall provide a copy of the application to the department's aviation office by certified mail, return receipt requested, or by a delivery service that provides a receipt evidencing delivery.

COMMENT: The Political Subdivision has apparently determined it has been provided a "complete permit application" by an applicant and has provided a copy to the department's Aviation Office by email. The department has waived delivery by certified mail and accepted service by email. Submission of the permit application to the AO is considered a representation that the Political Subdivision has zoning authority over the subject of the permit application.

3. Section 333.025(4) provides, in part, that:

To evaluate technical consistency with this subsection, the department shall have a 15-day review period following receipt of the application, which must run concurrently with the local government permitting process.

COMMENT: The AO has received a permit application, evaluated technical consistency and provided its Comments within 15 days of receipt of the permit application.

4. Section 333.025(4) provides, in part, that:

Cranes, construction equipment, and other temporary structures in use or in place for a period not to exceed 18 consecutive months are exempt from the department's review, unless such review is requested by the department.

COMMENT: The department has not been advised or provided information that proposed temporary structures will be used or in place for more than 18 consecutive months. Therefore it is assumed that the political subdivision is in compliance with this requirement.

It is presumed that the political subdivision has reviewed Chapter 333, Florida Statutes for requirements to comply with airport zoning regulations. It is further noted that s. 333.135(1), F.S. (2016) requires that any airport zoning regulation in effect on July 1, 2016, shall be amended to conform to the requirements of Chapter 333 by July 1, 2017. The department accepts the filing of the Airport Obstruction Zoning Permit Application with the ASO as a representation that the political subdivision has complied with the above requirements and that the political subdivision has zoning authority in this matter, unless otherwise advised in writing.

Failure to comply with the foregoing requirements may adversely impact the validity of any obstruction permit issued in response to this permit application.

These Comments do not constitute approval or disapproval of the permit application. The Comments are required by Section 333.025(4), F.S. to evaluate technical consistency.
