

Amendment No. 1 to Agreement No. 00275475.0



Hillsborough County Aviation Authority (“Customer”) and Environmental Systems Research Institute, Inc. (“Esri”) (collectively referred to as the “Parties”) entered into a Master Agreement Products and Services (“Agreement”) on October 3, 2019; and

The Parties wish to revise Initial Term of the Agreement and renew the term of the Agreement.

The Parties now amend the Agreement as follows:

1. Attachment B General Terms and Conditions, Article 2 – TERM AND TERMINATION of the Agreement is revised to state the following:

2.1 The initial term of this Agreement commences on October 3, 2019 and will continue through November 21, 2022 unless terminated earlier as provided herein (“Initial Term”). This Agreement may be renewed for one (1), three (3) year period at the discretion of the Customer and Esri. Such renewal will be effective by issuance of a written Amendment to the Agreement that is executed by both Parties. If all such renewals are exercised, this Agreement will have a final termination date of November 21, 2025. Customer may terminate this Agreement or any Esri Offerings license or subscription at any time upon written notice to Esri. Termination without cause does not entitle Customer to receive any refund of fees paid. Any right to terminate pending Services engagements for convenience is set forth in the applicable section in the body of this Agreement. Either party may terminate this Agreement or any license or subscription for a material breach that is not cured within 30 days of written notice to the breaching party. Upon any termination of this Agreement for breach, Esri will stop providing Services. Any licenses in Esri Offerings that survive termination of this Agreement continue under the terms of this Agreement.

2. Term Renewal

In accordance with the revised Article 2.1 of Attachment B of the Agreement above, the Agreement term is renewed for three (3) years commencing on November 22, 2022 through November 21, 2025, which shall be the final termination date of the Agreement.

All other terms and conditions of the Agreement, including any previous amendments, shall remain in full force and effect, except as amended herein. The Agreement and this Amendment are the sole and final agreement of the Parties and supersede any previous agreements, understandings, and arrangements relating to such subject matter. This Amendment is effective as of the date of the last signature shown below.
