# AMENDMENT NO. 1 TO USE AND PERMIT AGREEMENT FOR OFF-AIRPORT RENTAL CAR

#### CONCESSION

#### TAMPA INTERNATIONAL AIRPORT

THIS AMENDMENT to that certain Use and Permit Agreement for Off-Airport Rental Car Concession at Tampa International Airport, dated December 4, 2014, by and between the HILLSBOROUGH COUNTY AVIATION AUTHORITY, a public body corporate existing under the laws of the State of Florida (hereinafter referred to as the "Authority"), and CISCON, LLC D/B/A ACE RENT A CAR, a limited liability company organized and existing under the laws of the State of Florida and authorized to conduct business in the State of Florida (hereinafter referred to as "Company") (hereinafter individually and collectively referred to as the "Party" or "Parties") is made and entered into this 7th day of September, 2017 (hereinafter referred to as "Amendment No. 1").

#### WITNESSETH:

WHEREAS, on December 4, 2014, Authority and Company entered into a Use and Permit Agreement for Off-Airport Rental Car Concession at Tampa International Airport (hereinafter referred to as the "Agreement"); and

WHEREAS, Authority is constructing a consolidated rental car facility on the Airport (hereinafter referred to as the "ConRAC Facility"); and

WHEREAS, Company has entered into a Lease and Concession Contract for On-Airport Vehicle Rental Concession to occupy space in the ConRAC Facility, which was approved by the Authority Board of Directors on June 4, 2015; and

WHEREAS, opening of the ConRAC Facility to the public has been delayed from October 1, 2017 until February 1, 2018 and Company's Agreement expires September 30, 2017; and

WHEREAS, the Parties agree to extend the term of the Agreement until the later of January 31, 2018 or the date the ConRAC Facility opens to the public for commencement of operations.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby mutually acknowledged, the Parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.

- 2. This Amendment No. 1 is effective October 1, 2017.
- 3. ARTICLE 3, <u>TERM</u>, Section 3.02, <u>Term</u>, is hereby deleted in its entirety and replaced by the following:

### 3.02 Term

The term of this Agreement will commence on January 1, 2015 ("Commencement Date") and will continue through the later of January 31, 2018 or the date the ConRAC Facility opens to the public for commencement of operations.

4. Except as otherwise stated herein, all other terms of the Agreement remain in full force and effect and are hereby ratified and confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the Parties on the issues contained therein, either written or oral, and may be amended only by written instrument signed by both Parties.
