AMENDMENT NO. 3 TO CONTRACT FOR SPECIAL LEGAL SERVICES

THIS AMENDMENT NO. 3 to the Contract for Special Legal Services (Contract) dated May 5, 2016, by and between Hillsborough County Aviation Authority, a public body corporate under the laws of the State of Florida (Authority), and Hopping, Green & Sams, P.A., organized and existing under the laws of the State of Florida and authorized to do business in the State of Florida (Special Counsel), is entered into this 7th day of December, 2016.

1. Delete Article 3, <u>Compensation</u>, Section 3.2, <u>Not-to-Exceed</u>, in its entirety and replace with the following:

The amounts to be paid under this Contract shall not exceed \$150,000.

2. Except as provided herein, all other terms and conditions of the Contract remain in full force and effect and are hereby ratified and confirmed. The Contract, Amendment No. 1, Amendment No. 2 and this Amendment No. 3 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
