

ASSIGNMENT AND ASSUMPTION CONTRACT

THIS ASSIGNMENT AND ASSUMPTION CONTRACT is dated this ____ day of February 2017, between ABM Parking Services, Inc., a corporation organized and existing under the laws of the State of California and authorized to do business in the State of Florida (Assignor) and ABM Aviation, Inc. d/b/a ABM Parking Services, a corporation organized and existing under the laws of the State of Georgia and authorized to do business in the State of Florida (Assignee).

W I T N E S S E T H:

WHEREAS, on April 5, 2012, the Hillsborough County Aviation Authority (Authority) and Assignor entered into an Agreement for Parking Facilities and Shuttle Service Management Agreement; and

WHEREAS, Assignor desires to assign all of its rights and obligations under the Agreement to Assignee, and Assignee desires to assume all of Assignor's rights and obligations under the Agreement, on the terms and conditions hereinafter set forth; and

WHEREAS, the consent of Authority is required to effectuate this Assignment and Assumption Contract.

NOW, THEREFORE, Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Agreement effective as of February 2, 2017 (the Effective Date).
2. Assignee, for the benefit of Assignor and Authority under the Agreement, hereby assumes, and agrees to be bound by and to perform, all of the covenants, agreements, terms, obligations, responsibilities, provisions and conditions on the part of the Assignor under the Agreement to be kept, performed and observed from and after the Effective Date.
3. This Assignment and Assumption Contract shall be binding upon and inure to the benefit of the parties' respective successors and assigns.
