

Noise Monitoring Office Update

Runway 1R Jet Landings

The FAA Tower cleared **41% fewer** jet landings on Runway 1R year-over-year.




Inclusive of Commercial and Corporate Jet Landings



Commercial Jet Pilot Compliance March - April, 2017

- For March and April, 2017, commercial jet pilot compliance was 99.9%.
 - The FAA Tower cleared 26 commercial jet pilot request deviations out of 29,033 commercial jet landings and departures for the period.







Corporate Jet Pilot Compliance March – April, 2017

- Corporate jet operations accounted for 9% of the total jet operations at TPA for the reported period.
- Corporate jet aircraft were 90% compliant with the Airport's Voluntary Noise Abatement Program for the reported period.






Jet Landings By The Numbers... March – April, 2017

South Flow:

 During 'south' flow operations, jet landings are split between Runway 19R and Runway 19L.

North Flow:

• During 'north' flow operations, jet landings are concentrated to Runway 1L.

Metroplex (NextGen)

Metroplex (NextGen) – Key Facts



- Congressional mandate to the Federal Aviation Administration (FAA) to transform the National Airspace System.
- Primary component is implementation of Performance Based Navigation (PBN), moving away from ground based navigation to satellite based navigation.
- South-Central Florida implementation (including TPA) not expected for at least 24-36 months.
- Majority of NextGen expected to be <u>fully implemented by 2020</u>.



More to Come on Metroplex...

- FAA is the agency implementing congressionally mandated modernization of the National Airspace System.
- Airport last met with the FAA regarding Metroplex in February 2017.
- The FAA advised the Airport in April that an internal FAA timeline for outreach and community engagement was being reevaluated. No further information has been provided.
- Hillsborough County Aviation Authority is committed to:
 - Community engagement on Metroplex.
 - Making sure residents and stakeholders are involved in the process to the greatest extent possible allowed by the FAA.
 - We welcome the opportunity to engage with your HOA to help encourage your community to participate in public FAA meetings, when they are scheduled.

Upcoming Runway Closures

Twice Annual Rubber Removal

- Rubber removal is required at least twice annually on all of the Airports four primary runway ends.
 - This required process removes rubber build-up left by landing aircraft.
- This work is expected to begin Monday, June 5, 2017
 - We expect work to take place during daytime hours.
 - Specific times will be communicated closer to June 5.
