


Construction Projects Update

- Runways 1L-19R, 10-28 and Associated Taxiways Joints and Slab Rehabilitation Project:
 - Runway 1L-19R was reopened on October 22, 2013 as scheduled.
 - Runways 10-28 is scheduled to close on December 2, 2013 and will reopen on December 25, 2013.
 - Runway 1R-19L is scheduled to be closed for 30 days starting January 2, 2014. All traffic will be assigned Runway 1L-19R for takeoffs and landings.
- FAA Runway Sterilization Project: On Hold due to the Government Shutdown
 - Relocates FAA navigational equipment currently located inside Runway 1L-19R safety area will cause Runway 1L-19R to be closed <u>nightly</u> between the hours of 1:00 a.m. until 8:00 a.m.




Q3 '13 Jet Turns North of MacDill A.F.B.

- Commercial & Cargo = 153
- Corporate = 48
- Jet turns north of MacDill's Runway 4 represented 3% of the total arrivals (6,744) during a north flow this quarter.
- The percentage was high due to the closure of Runway 1L-19R.



Comparison to CY Q3 '12

- → Jet landings on Runways 1R & 1L combined, increased by 170 to 6,744.
- → Pilots requested landings increased by seven from 80 to 87. The increase is almost equally divided between the two operators, corporate and airlines and cargo pilots.
- → FAA assigned landings decreased by 75% or from 33 to 8.
- → Overall, jet landings on Runway 1R increased by 716 due to Runway 1L-19R closure.


Comparison to Q3 '12:

- → FAA assigned departures decreased by 100%.
- → Pilot requested departures decreased by 78% or 14.
- → Airport Issues assigned departures increased from 249 to 703 due to the closure of Runway 1L-19R for construction.



Q3 '13 Noise Complaints

- Total of 42 noise complaints from 15 individual households
 - 8 fewer complaints than the previous quarter.
 - 31 fewer complaints from the same quarter a year ago.
- Six repeat callers accounted for 33 or 79% of the total complaints.
- Frequent types of noise complaints:
 - 74% Jet Landings on Runway 1R
 - ▶ 14% Loud
 - ≻ 5% Low
- Geographical location of majority of noise complaints:
 - → Beach Park 28
 - → Sunset Park & Belmar Shores 8
 - → Dana Shores 4
