- Complete computerized IET Movement Driver Training Course (provided via badging office)

- 139.303(c) (2) Procedures for access to, and operation in, movement areas and safety areas, as specified under 139.329
- 139.303(c) (3) Airport Communications, Noncomplying Conditions 139.343, and Airport Condition Reporting 139.339

- > 139.311 Markings, Signs, & Lighting
- > 139.313 Snow and Ice Control
- > 139.323 & 139.331 Traffic and Wind Indicators and Obstructions Lighting
- Airport Emergency Plan (AEP)
- > 139.335 Public Protection
- 139.303(c)(5) Additional subject areas as required:
 - > 139.319 Aircraft rescue and firefighting: Operational requirements
 - > 139.321 Handling and storing of hazardous substances and materials
 - > 139.327 Self-inspection program
 - > 139.337 Wildlife hazard management
